TRANSFER OF TITLE - NO OCCUPANCY

<u>BUYERS/SELLERS</u>: For properties that cannot pass the Certificate of Continued Occupancy (C.C.O.) inspection prior to the closing, the township can provide a "TRANSFER OF TITLE – NO OCCUPANCY" document for closing purposes. In order to receive the document, please complete the following steps:

1. The Certificate of Continued Occupancy (C.C.O.) application & Fire application must be submitted with payments to the Housing Department. Please mail or deliver to:

- 2. After submitting the two applications and two payments, please schedule C.C.O./Fire inspections.
- 3. <u>It is a New Jersey State requirement for all properties to pass the Fire inspection prior to the sale</u>. Please refer to New Jersey Residential Smoke Alarm, Carbon Monoxide and Fire Extinguisher Requirements. Please complete the requirements <u>prior</u> to the first inspection appointment to avoid any delays.
- 4. At the appointment, the inspector will list any deficiencies for the property and/or may list a deficiency called "too many items to list". If there are "too many items to list", please refer to the entire list of Requirements for the Certificate of Continued Occupancy.
- 5. The buyer(s) is aware the property did not pass the C.C.O. inspection. Then, the buyer's attorney must draft a "Transfer of Title No Occupancy" letter. Please see the sample letter and follow the sample the exact way it is written. The attorney and the buyer(s) must sign the letter.
- 6. After the property passes the Fire inspection and the "Transfer of Title No Occupancy" letter is submitted to the Housing Department, the Housing Department will email the "Transfer of Title No Occupancy" document for closing.
- 7. After closing, the buyer is responsible to handle the outstanding deficiencies. When completed, please call the Freehold Township Housing Department and schedule the final C.C.O. inspection @ 732-294-2066. After it passes, the "actual" Certificate of Continued Occupancy will be issued for the property.
