A motion to accept the minutes as presented made by Commissioner Lau and seconded by Commissioner Higley. All in favor.

• Correspondence –

Email request from Pat Lawlor, Commander American Legion Post 54 requesting permission for the Legion to use the park for a wine tasting fundraising event end of September / October. Discussion of other events in September, certificate of insurance, areas they will using and porta johns.

Old Business

• Weed Maintenance – Commissioner Kane introduced Neil Herstik. Mr. Herstik gives his background of being on the commissioner and continues to speak about the lake and the condition it has been in. He began outlining the treatments, studies done, types of remediation that can be done to clean up the lake and to keep the lake alive. Mr. Herstik spoke about the costs involved and how they would be divided up between the Township and Borough. He requested the commission continue to look for a long term solution, to keep him abreast of the decisions to continue with remediation and thanked the commission for listening to his concerns. Discussion of re-evaluations, clarity of water, types of remediation, contacting Monmouth County to see how they will handle a similar problem they are having at the Manasquan Reservoir.

- Paddleboats Commissioner Kane states that the boats need to be pulled out of the water and secured for the winter. A clean up date was set for October 8, 2016 9:00 am.
- Fund Raising No report at this time.
- Band Shell Kirk Tibbett explained he was able to reduce the price by using different materials. He stated that he would take care of filling out the permits and submit a drawing. Discussion of removal of additional trees and how long to build.
- Parking Commissioner Kane reported on some of the recommendations made by Bill Wetson, Freehold Borough Engineer of how to set up the parking area using all the area back to the tree line and using logs to make two lanes of parking spaces.
- Monmouth County Inmate Program Commissioner Kane reminded the commission that the Monmouth County Inmate Program would begin this week and set up a list of projects for them.
