Kane reported that Joe Bellina will talk to Freehold Township in regards to the cost.

- Band Shell Kirk Tibbet reported that half of the decking is down and in the process of piece in around the corner posts, next big step will be the roof structure. Set up date: December 30, 2017 at 9:00am.
- Projects for 2017 and beyond Commissioner Kane reported that he had a meeting with Joe Bellina and the borough engineer and they want to move forward in putting the bridge in over the dam by next spring. Mr. Tibbett reported that he spoke with the bridge company and got information about the cost, time line and size of the bridge (5'x50'). They told him they had an express bridge option for one that was a little bigger (6.2'x50') and a little more expensive but that they would meet the price. It is steel with wood decking.
